NINTH AMENDMENT TO AGREEMENT FOR PROFESSIONAL LEGAL SERVICES

Pursuant to Paragraph 26 of the AGREEMENT FOR PROFESSIONAL LEGAL SERVICES ("AGREEMENT") between the County of Santa Barbara ("COUNTY") and the Meyers|Nave law firm ("CONTRACTOR"), the COUNTY and CONTRACTOR amend the AGREEMENT as follows:

<u>TERM</u>. CONTRACTOR shall commence performance on August 28, 2018 and end performance upon completion, but no later than January 31, 2026, unless otherwise directed by COUNTY or unless earlier terminated.
