Recommended Actions:

That the Board of Supervisors:

- a) Approve and authorize the contribution of \$10,000 to Northern Santa Barbara County Athletic Roundtable, a 501(c)(3) nonprofit (EIN # 77-0419353), from the Fifth District General County Programs Department 990 discretionary fund;
- b) Approve Budget Revision Request No. 0011144 to increase Appropriations of \$9,000 in the General County Programs General Fund for Services and Supplies, funded by a release of Committed Emerging Issues fund balance;
- c) Find that the project provides a community benefit that meets the social needs of the County; and
- d) Determine that the above actions are organizational or administrative activities of the government that will not result in direct or indirect physical changes in the environment and are not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(5) of the CEQA Guidelines.

Summary Text:

This action will authorize a \$10,000 contribution to Northern Santa Barbara County Athletic Roundtable. These funds will be used to augment the scholarship activities of the Athletic Roundtable, where, in addition to an annual banquet honoring local athletes, \$12,500 is given to student athletes to help fund their college tuition.

Background:

Upon adoption of the County’s FY 2023-24 Budget, each supervisorial office was allocated \$100,000 of discretionary funding to direct toward projects and/or programs in the County in need of funding. These funding requests must be approved by the full Board of Supervisors.

Fiscal and Facilities Impacts:

Budgeted: \$1,000 of the total \$10,000 donation amount is currently appropriated in the General County Programs General Fund. The remaining \$9,000 will be budgeted with approval of Budget Revision Request No. 0011144.
