

## **FOURTEENTH AMENDMENT TO SOFTWARE SUPPORT AGREEMENT WITH TRITECH SYSTEM**

**THIS FOURTEENTH AMENDMENT** to the System Agreement dated June 27, 2006 with Contractor TriTech Software Systems, a CentralSquare Technologies company, (hereafter "TriTech") is made and entered into this 28<sup>th</sup> day of June, by and between the County of Santa Barbara, a political subdivision of the State of California (hereafter "County") and TriTech Software Systems (hereafter "Tritech"), (hereafter the "Fourteenth Amendment"). For purposes of this Fourteenth Amendment, the County and TriTech shall be referred to collectively as the "Parties."

WHEREAS, the Parties entered into an initial agreement to purchase TriTech's CAD system on June 27, 2006 (hereafter the "Agreement"), with an annual Software Support Agreement;

WHEREAS, the Parties renewed the Software Support Agreement with an effective date of April 1, 2021;

WHEREAS, the County previously purchased Unify CAD-to-CAD from TriTech and incorporated it into the Agreement as Exhibit K; and

WHEREAS, the parties desire to Amend the Agreement to:

- (1) Extend the software support included in the original Agreement for an additional year from April 1, 2022 to March 31, 2023.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the receipt and sufficiency of which are hereby acknowledged, it is mutually agreed upon as follows:

- (1) The term of the Agreement, Section 4, Term, is extended from April 1, 2022 to March 31, 2023 for the renewal of Software Support Agreement in the amount of \$206,311.50, for the Software specified in Invoice No. 344746, which is due upon execution of this Fourteenth Amendment.

In all other respects, the terms and conditions of the Agreement shall continue unchanged and in full force and effect.
