Recommended Actions:

That the Board of Supervisors:

- A. Approve and authorize the Chair to adopt a Resolution establishing a new “no parking” zone on San Marcos Road in the Goleta area; and “no parking” 2 a.m. to 6 a.m. zone on Vala Drive in the Goleta area; Second Supervisorial District; and
- B. Find that the proposed action is for the operation and maintenance of existing public facilities, involving negligible, or no expansion of use beyond that which presently exists, that the proposed action is therefore exempt from CEQA pursuant to 14 CCR 15301, and approve the filing of a Notice of Exemption on that basis.

Summary Text:

San Marcos Road (Second District)

Public Works was notified of parking issues on San Marcos Road, north and south of University Drive. The Department investigated the location and confirmed that a safety hazard exists where the lane and roadway width on a short segment of San Marcos Road is too narrow to permit parking. The Department recommends parking restrictions at the following locations:

- West side of San Marcos Road, from a point 190 feet north of the centerline of University Drive to the centerline of University Drive, and
- East side of San Marcos Road, from a point 190 feet north of the centerline of University Drive to a point 200 feet south of the centerline of University Drive.

Vala Drive (Second District)

Public Works was notified of parking issues on Vala Drive, south of Cathedral Oaks Road. Residents reported the roadway was being used for long term storage of vehicles at locations where houses did not front the roadway. The Department investigated the location and confirmed that vehicles were being

stored at these locations and that the vehicles would be moved periodically to avoid towing. At the request of the residents, the Department is presenting the request for overnight parking restrictions at the following locations:

- West side of Vala Drive, from the centerline of Cathedral Oaks Road to the centerline of Yaple Avenue, and
- East side of Vala Drive, from the centerline of Cathedral Oaks Road to the centerline of La Ramada Drive.

RESOLUTIONS:

Public Works has prepared the attached resolutions to establish parking restrictions at the following locations:

ADOPT

No Parking Zone

- On the east side of San Marcos Road, from a point 190 feet north of the centerline of University Drive to a point 200 feet south of the centerline of University Drive (*Second District*)
- On the west side of San Marcos Road, from a point 190 feet north of the centerline of University Drive to the centerline of University Drive (*Second District*)

No Parking 2 a.m. to 6 a.m. Zone

- On the west side of Vala Drive, from the centerline of Cathedral Oaks Road to the centerline of Yaple Avenue (*Second District*)
- On the east side of Vala Drive, from the centerline of Cathedral Oaks Road to the centerline of La Ramada Drive (*Second District*)

Background:

Parking restrictions are either established or rescinded based on safety, necessity, and how they relate to the community’s use as a whole. Public Works weighs all of these factors and presents any recommended changes to the Board of Supervisors for approval. These parking restrictions may include no parking, time limited parking, loading zones, vehicle height restricted parking, angle parking, handicapped parking, or any combination of these restrictions.

Public Works has surveyed the locations described above, and determined that parking restrictions in these locations would be in the best interest of the communities and the traveling public. In addition, the request to install the no parking zone came from the community into the Second District Supervisor’s office. Public Works requests your Board’s approval of the two attached Resolutions to implement these parking restrictions.
