Dear Board of Supervisors,

Re: Funding for Santa Barbara Public Library

I am writing to strongly advocate for your continued financial support of the Santa Barbara Public Library and request that you take a long-needed hard look at library funding in our region.

Despite the many fiscal challenges of the past few years, in addition to the logistical pivots required during the pandemic, the Santa Barbara Public Library has done an impressive job of providing an extensive array of services to our region.

The library depends on county funding for important programs such as Student Success Cards, which support more than 10,000 Santa Barbara Unified School District students with library cards and services; the Library on the Go outreach program, which takes the library to underserved areas such as local parks and Housing Authority sites; adult literacy programs; caregiver classes for Spanish speakers — the list goes on and on and on.

Despite the rich and unique services the Santa Barbara Public Library provides, the county formula has continued to prioritize smaller regional libraries over the larger municipal library. It's time to give Santa Barbara a fairer share of the funding. **Santa Barbara Public Library currently receives per capita dollars from the County for 99,424 people and Goleta receives per capita dollars from the County for 92,382 people, despite the fact that Central Library has 52,211 total registered users and Goleta Library has 15,693 total registered users.** The city of Santa Barbara also has a high rate of the population living below the poverty line (12.5% vs. 7.9% in Goleta) and a higher number of people who are not fluent in English (12,841 vs. 3,946 in Goleta).

I urge you to please take all of these factors into account as you review your budgets and consider providing additional funding to the Santa Barbara Public Library.
