RECOMMENDATIONS:

That the Board of Supervisors:

- 1. Approve the Project and Categorical Exemption pursuant to the County's California Environmental Quality Act (CEQA) guidelines for the Traffic Signal Replacement at Turnpike Road / Calle Real intersection.
- 2. Authorize the Director of Public Works to advertise for construction bids for the Traffic Signal Replacement at Turnpike Road / Calle Real intersection.
- 3. Authorize the Public Works Director or his designee to execute the terms of the grant.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Strategic Plan Goal No. 1: An efficient government able to anticipate and respond effectively to the needs of the community.

EXECUTIVE SUMMARY & DISCUSSION:

The County Public Works Department operates and maintains county-owned traffic signals throughout the unincorporated area. The Department has identified the signal at the intersection of Turnpike Road and Calle Real as a candidate for upgrading due to the fact that the left turn signals on Turnpike Road are atgrade and there currently is no left turn phase for motorists traveling east-west on Calle Real who wish to turn onto Turnpike Road.

The upgrade proposal consisted of the removal and replacement of the at median-mounted signals on Turnpike Road with curb-mounted overhead signals and the installation of a left-turn phase signal on Calle Real so that motorists traveling east-west would no longer need to wait for a gap in oncoming traffic in order to make a left onto Turnpike Road, north or south.

Pursuant to the County's CEQA guidelines, the project has been determined to be exempt from further environmental review. Approval of the Notice of Exemption shall indicate the Board of Supervisor's approval of the project and will commence the appeal period, pursuant to CEQA guidelines.
