That the Board of Supervisors:

- A. Approve the vacation of a portion of the public right-of-way known as Sabado Tarde and El Embarcadero in Isla Vista as defined on Parcel Map No. 14,759 by authorizing the Clerk of the Board to sign said map. The consummation of the vacation is subject to completion and recordation of the subject map.
- B. Approve the acceptance of public utility easement as defined on Parcel Map No. 14,759 by authorizing the Clerk of the Board to sign said map. The consummation of the acceptance is subject to completion and recordation of the subject map.

Summary Text:

The County Surveyor's Office is reviewing Parcel Map No. 14,759 (APNs 075-173-023 & -024) which properties are located in Isla Vista, (Third Supervisorial District). If recorded the above Map will combine the two referenced parcels, vacate right-of-way on Sabado Tarde and El Embarcadero held by the County in easement, and will accept a public utility easement. The area of the proposed public utility easement is shown on Page 1 of 2 of the attached exhibit. The area proposed for vacation is located along the southern and western edges of APN 075-173-023, and along the western edge of APN 075-173-024 as shown on Page 2 of 2 of the exhibit attached hereto. Neither the acceptance or vacation will be consummated until the subject Parcel Map is recorded. Prior to recordation the County Surveyor will be satisfied that the subject Parcel Map is technically correct, conforms to the approved Tentative Map (or approved alterations thereto), and complies with all applicable laws and regulations.
