Justification:

On October 8, 2013 the Sheriff's department went to the Board with a presentation and report on the opportunity to expand the Northern Branch Jail using funding provided by SB1022. At that time a budget revision was approved in the amount of \$3,900,100 transferring from the Strategic Reserve Committed Fund Balance Account to the SB1022 Committed Fund Balance Account in the Sheriff's department General Fund. This Budget Revision Request will transfer the fund balance from the SB 1022 Committed Fund Balance in the Sheriff's Department General Fund to the newly established North County Jail STAR SB1022 Committed Fund Balance. This budget revision will also provide the necessary appropriation to fund the initial efforts in the amount of \$220,000 for the Northern County Jail STAR SB1022 project from matching fund requirements.

The team will come back to the Board in 2015 when the details of the consultant professional services agreements are finalized and will request appropriation

of the remaining budget for the 2014/2015 fiscal year.

Justification: This budget revision is necessary to increase appropriations in the amount of \$1,400,000 in the Public Health Department Pharmacy program for the

replenishment of pharmaceuticals for the 340B Contract Pharmacy Program and to decrease the release of restricted fund balance in the amount of \$700,000.

This pharmaceutical replenishment and the reduction of the release of restricted fund balance is funded by unanticipated revenue from the 340B Contract

Pharmacy Program in the amount of \$2,100,000.

The 340B Contract Pharmacy Program is a joint venture between the Public Health Department, CenCal Health, and certain area pharmacies. A recent

change by CenCal to include specialty pharmaceuticals in the program has necessitated this budget revision.

Justification: This budget revision would provide budget authority for the Department to fund a \$95,000 contract to prepare an Environmental Impact Report for the Winery

Ordinance Update Project. This contract is necessary in order for the project to remain on schedule as proposed in the Long Range Planning Division's Annual Work Program approved by the Board. As a result of unanticipated staff turnover in the Long Range Planning Division, over \$100,000 in salary savings has been generated in the Division in the first quarter of this fiscal year. This budget revision would provide budget authority for the Department to

use \$63,000 of this salary savings and \$32,000 of departmental committed fund balance to fund the contract expenditures.
