Approve and authorize the Public Works Director to advertise and receive bids for the Via Rueda Interceptor Storm Drain Project Phase II.

Summary Text:

This project consists of constructing approximately 225 linear feet of 30" diameter storm drain in Puente Drive, in the unincorporated area of eastern Goleta Valley. The project will connect the downstream terminus of Via Rueda Interceptor Storm Drain Phase I to Atascadero Creek. Phase I was completed in 2007 and was designed to improve the drainage of Vieja Drive, located above Via Rueda, and relieve the Flood Control District's maintenance staff from having to further maintain the remaining portions of the previously existing drainage system through the quitclaiming of easements. Phase II represents the final phase of this project.

The completion of this project will improve drainage and decrease flooding potential to the Via Rueda neighborhood.
