#### ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendations are primarily aligned with Goal No. 2. Ensure the Public Health and Safety and Provide Essential Infrastructure.

#### **EXECUTIVE SUMMARY:**

The Board has set June 3, 2003 as the hearing to introduce an ordinance (first hearing) entitled, "An Ordinance Amending Ordinance 3150, the Flood Control Benefit Assessment Ordinance, Relating to Benefit Assessments for Flood Control Services"; and has set June 17, 2003 as the second hearing. Upon adoption of the Resolution presented, the Board will have confirmed the assessments as presented in the Report.

A copy of the report will be kept on file with the Clerk of the Board until the conclusion of the hearings.

CEQA does not apply to the increase of rates by the Consumer Price Index (CPI) pursuant to Title 14, California Administrative Code Section 15273 (a)(1)(2)(3)(4).

### **MANDATES AND SERVICE LEVELS:**

Adoption of this Board of Directors Ordinance is recommended to continue the current level of flood control services.

#### FISCAL AND FACILITIES IMPACTS:

Santa Barbara County residents approved, by vote, the levying of benefit assessments to help pay the cost of providing flood control services. The ordinance that established the assessment program allows for annual increases in assessment rates up to the increase in the CPI for the preceding twelve months. It is proposed to increase the rates in each zone for Fiscal Year 2003-04 by 3.7% as determined by the State Department of Finance.

The new assessment rate increase should generate approximately \$2,260,000, which represents an estimated increase of \$81,000 from which the District currently receives collectively within the zones. The CPI increases are intended to equalize service levels year-to-year by stabilizing buying power. The new benefit assessment rates prevent the devaluation of District revenues from inflation.

The benefit assessment increase is revenue anticipated for the Water Resources Division in the Proposed Budget for 2003-04 under Other Charges for Services.

# ATTACHMENT A Update on the South Coast Benefit Assessment Increase March 1996 Election

In March of 1996, the voters on the South Coast approved an assessment increase above the CPI to help fund not only on going maintenance but capital projects as well. The 1996 increase was clearly worded to show the voting public that the proposed assessment increase would be used for flood control purposes. Below is a summary of the major projects completed on the South Coast since the March 1996 Election.

Currently, staff is working on several other major projects on the South Coast. A summary of the active projects is listed below.

#### Mission Creek

The Mission Creek Flood Control Project is beginning the final design process. The first major expenditure of local funds will be for the right-of-way (ROW). The ROW costs will be several million dollars and that element is a local cost. Initial work will begin next fiscal year. Construction is currently scheduled for 2008. The City will initiate some of the bridge replacements earlier.

## Las Vegas / San Pedro Creeks

Staff has been working for several years on coordination of a project to replace culverts on Las Vegas and San Pedro Creeks. The project involves coordination between the City of Goleta, City of Santa Barbara, UPRR, and Caltrans. The project would reduce serious flooding in the neighborhoods north of Calle Real near Vega Drive and Valdez Avenue.

# **Carpinteria Salt Marsh**

While several upstream elements of the Carpinteria Salt Marsh project have been completed. Soon the project EIR will be coming before your Board for consideration. Within this EIR is the main flood control element of the project as well as other enhancements that will be pursued by other agencies (State, Land Trust, etc.).

# **El Encanto Debris Control Project**

This project is located near St. Francis Hospital. Design is nearing completion and property acquisition has been initiated. Construction is anticipated this fall.
