NOTICE OF PUBLIC HEARING

**NOTICE IS HEREBY GIVEN** that, pursuant to the provisions of Section 54985 of the Government Code, fee rates for the Department of Public Works Water Resources Flood Control District and Department of Public Works Water Resources Project Clean Water have been determined by the rates necessary to recover the cost of providing those services. **NOTICE IS FURTHER GIVEN** that on Tuesday, September 15, 2020, at 9:00 a.m. in the Board of Supervisors Hearing Room, the Board of Directors of the Santa Barbara County Flood Control & Water Conservation District and the Board of Supervisors of Santa Barbara County shall introduce an ordinance (first reading) entitled "An Ordinance Adopting a Schedule of Fees for Services Provided by the Department of Public Works, Water Resources Flood Control District in Connection With Providing Services Within the Jurisdiction of Santa Barbara County" and an ordinance (first reading) entitled "An Ordinance Adopting a Schedule of Fees for Services Provided by the Department of Public Works, Water Resources Project Clean Water in Connection With Providing Services Within the Jurisdiction of Santa Barbara County."

On Tuesday, September 22, 2020 at 9:00 a.m., or soon thereafter in the Board of Supervisors Hearing Room, the Board of Directors of the Santa Barbara County Flood Control and Water Conservation District and the Board of Supervisors of Santa Barbara County, shall hold a Public Hearing (second reading) of the Ordinances referred to above for the purposes of considering and approving the adoption of those Ordinances, at which time and place said Board will hear and consider all protests to said Ordinances, if any, including protests with respect to the amount of the proposed fees to be adopted. At the conclusion of the hearing, the Board may adopt, revise, change, reduce or modify any fee and shall make its determination upon each fee described in the Ordinances, and thereafter by resolution, the Board shall confirm the fees, which are finally adopted and levied.
