## **Recommended Actions:**

Set May 17, 2011 hearing to consider the Hollister Yacono Consistency Rezone, Development Plan, Conditional Use Permit and Overall Sign Plan of the Planning Commission's approval on February 9, 2011 of 09RZN-00000-00010, 07DVP-00000-00028, 10CUP-00000-00043, 08OSP-00000-00001. Assessor Parcel No. 099-640-010, commonly known as 2201 U.S. Highway 101, located approximately 2 miles north of the City of Buellton and 1.5 miles south of the Highway 101 and Highway 154 interchange. Site access is from Jonata Park Road, Buellton area, Third Supervisorial District. At the May 17, 2011 hearing, the Board of Supervisors action should include the following:
