- thence along the northerly line of Parcel C of said Parcel Map No. 11691, being the southerly boundary of said annexation per Resolution No. 86-650, South 89° 51' 45" East, 992.27 feet to the northeasterly corner of Parcel C of said Parcel Map No. 11691, being a point on the westerly line of the annexation to County Service Area No.5, adopted by the Santa Barbara Board of Supervisors per Resolution No. 79-553, recorded December 28, 1979, as document 79-60444, records of said County;
- 3 thence along the easterly line of Parcel C of said Parcel Map No. 11691, being the westerly line of said annexation per Resolution No. 79-553, South 0° 45' 46" West, 655.09 feet to Point "K" as shown on said Parcel Map No. 11691;
- 4 thence continuing along the easterly line of Parcel C of said Parcel Map No. 11691, being the westerly line of said annexation per Resolution No. 79-553, South O° 12' 04" West, 1254.35 feet to the southeasterly corner of Parcel C of said Parcel Map No. 11691, being the southwesterly corner of said annexation per Resolution No. 79-553, also being the northeasterly corner of the annexation of the Oak Knoll Lighting District to County Service Area No.5, adopted by the Santa Barbara County Board of Supervisors per Resolution No. 23626, adopted November 18, 1963;
- thence along the southerly line of Parcel C of said Parcel Map No. 11691, being the northerly line of said annexation per Resolution No. 23626, South 89° 59' 06" West, 765.07 feet to the most southwesterly corner of Parcel C of said Parcel Map No. 11691, also being the southeasterly corner of Parcel A of Parcel Map No. 12864, as shown on the map filed in Parcel Map Book 23, Page 30, records of said County;
- thence along the southerly line of Parcel A of said Parcel Map No. 12864 and its westerly extension, being the northerly line of said annexation per Resolution No. 23626, South 89° 55' 59" West, 553.74 feet to the intersection with the westerly line of said Section 11, being the northwesterly corner of said annexation per Resolution No. 23626;
- thence northerly along the westerly line of said Section 11, North 0° 17' 46" East, 1228.56 feet more or less to the northwesterly corner of said Section 11, being the southwesterly corner of said Section 2;
- 8 thence northerly along the westerly line of said Section 2, North 0° 17' 46" East, 684.87 feet more or less to the Point of Beginning.

The above described portions of Sections 2 and 11 contain 57.8 acres and are shown on EXHIBIT B, attached hereto and made a part hereof for informational purposes only.
