Dear County Supervisors:

I am writing in support of community demands to:

- 1. Update the Sheriff's Office Use of Force policy to ban Carotid Restraints and shooting at moving vehicles, as well as requiring deputies to intervene when others are using excessive force.
- 2. Create a civilian review board to investigate police misconduct
- 3. Provide mental health and substance abuse treatment services before arrests.
- 4. End all plans to construct a new county jail.
- 5. Terminate all cooperation between ICE and the Sheriff's office.
- 6. Commit to investing in youth programs
- 7. Reject all proposals to increase police spending in Goleta and other cities contracting with the Sheriff's Office.

Creating a more restrictive Use of Force policy is necessary as an immediate harm reduction strategy. But these reforms in policy are ultimately toothless without Community Control of the police. My name is Morgan Fredricks - I have been a resident of Santa Barbara for 8.5 years and am writing in support of the demands outlined by Juneteenth and Healing Justice: BLM SB. I urge the board to take immediate action on the following items:

- End Cooperation Between SB County Sheriff and ICE. We know that ICE is evil and inhumane. We see it on the news, we hear about it from our fellows. We as a community need to acknowledge that what they do is wrong and protect our community members from ICE.
- Disband internal sheriff-only investigations and create a civilian review board to investigate police misconduct. I cannot think of a better way to ensure the police are held accountable and performing to the standards dictated by those they are supposed to be serving and protecting. Sheriff Bill Brown will try to tell you that this is unnecessary, that we do not experience misconduct or violence or racism here, and that they hold themselves accountable just fine. IF that is the case, then there should be no fear in creating such a civilian review board. Let us be the judge of the job that is being done. Let us hold these officers, who are funded with our tax dollars, to the standards we wish to see in our communities.
- Commit to investing in Youth and de-investing in education. Education can be a preventative factor in crime. Education empowers young people to achieve their dreams and imagine a better world. We are not adequately funding our schools, paying our teachers or funding necessarily mental health resources for youth (and college students, and adults). Please use funds previously allocating to policing for education and youth programs instead.
- Provide mental health substance abuse treatment and rehabilitation services before arrest. This should NOT just apply to non-violent crimes as Proposition 36 suggests. We have all seen how police can escalate a non-violent situation into an at times deadly one. I worry that saving this resource for only non-violent offenders does not solve any problems. Please allow all drug-related charges a chance at rehabilitation and fund programs so that scholarships can be provided to those who cannot pay for these programs on their own. As a recovered addict and convict of a violent drug-related crime, I cannot emphasize enough how important rehabilitation is to truly changing these behaviors for the long-run. Lessons are not learned and lives are not changed behind bars.
- If the new jail is indeed "almost done" as Sheriff Brown suggests, and it is going to be a nicer facility than our previous jail, I expect ALL current inmates to be moved to that facility IMMEDIATELY

upon its completion. If that is not the plan then stop funding to the jail because this is a waste of our time and money.

Hi, the following is a public comment for today's Santa Barbara Board of Supervisors Hearing on Racial Equity and Criminal Justice.

As a member of the Santa Barbara community, I demand, first and foremost, that the city divests from policing and reinvests in resources such as after school programs, restorative justice, implicit bias training, mental health services, community programs emphasizing diversity, and more. To this end, the city needs to use racial equity as a lens to bridge the gap between Santa Barbara's low-income communities of color and it's wealthy (mostly white) counterparts. This divestment from SBPD should also include halting all plans to construct a new county jail.

In addition, SBPD must dramatically alter its use of force policies to prioritize de-escalation. This includes banning the use of brutally inhumane chokeholds, strangleholds, and shooting at moving vehicles. Police officers should be required to exhaust all alternatives before deploying their firearm, and again, the priority should be de-escalation. For police officers with a proven record of misconduct and/or excessive use of force, a civilian review board must be created to investigate said individual and eliminate the bias and conflict of interest that is inevitable in an internal, sheriff-only review board.

Lastly, I ask that the Sheriff's Department prioritize the safety, freedom, and unalienable right to liberty of its community members and END cooperation with ICE. Using taxpayer dollars, ICE has committed heinous crimes against humanity, including the torture, rape, killing, and imprisonment of individuals in concentration camps.
