Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, Mendez Concrete, Inc., (not a local vendor), 1210 Santa Paula Street, Santa Paula, California 93060, in the amount of \$280,421.83.

Summary Text:

As part of the Public Work Departments' annual Pavement Preservation Program, this project consisted of installing new hardscape to complete missing segments or repairing existing hardscape by the removal and replacement of damaged concrete curbs, gutters and sidewalks, installing ADA compliant curb ramps, and tree root pruning and shielding. Approximately 240 linear feet of sidewalk, 110 linear feet of curb and gutter and 21 curb ramps were repaired, as well as 540 linear feet of new sidewalk and 110 linear feet of new curb and gutter were installed with the construction of this project.

The Director of Public Works accepted this project as complete on March 16, 2007. The project was completed on time and on budget.

Background:

The Board approved this project as part of the FY 2006/07 Capital Improvement Plan. The specific project locations were approved by the Board in the FY 2006/07 Road Maintenance Annual Plan (RdMap) on March 28, 2006 and are attached for your information. (See Attachment B)
