

Amendment No. 2 to the Contract with Alternative Resources, Inc. for consulting services to evaluate the feasibility of conversion technology at the Tajiguas Landfill (BC No. 08-063)

The agreement between the County of Santa Barbara (County) and Alternative Resources , Inc. (CONTRACTOR) which was entered into on October 16, 2007 (Board Contract No. 08-063), is hereby modified and amended as follows:

1. Paragraph 4 of the Agreement is hereby amended to read:

TERM. The term of this contract shall be twenty-two and a half (22 ½) months, commencing on October 16, 2007, and expiring August 31, 2009, subject to extension as provided herein. Notwithstanding the foregoing, the unexcused failure or refusal of CONTRACTOR to perform any material term, covenant, obligation or condition contained in this contract shall give rise to the right, in favor of County, for earlier termination of this contract.

2. Exhibit A Section II. Scope of Work Paragraph A. is hereby amended to read:

A. There are seven (7) specific tasks that should be accomplished:

3. Exhibit A Section II. Scope of Work Paragraph A. items 6 and 7 are added:

6. Joint Powers Agreement and/or Memorandum of Understanding formation assistance (if directed)

a. CONTRACTOR will assist in the development of the contractual or structural arrangement the participating jurisdictions will sign onto for the possible development of a Conversion Technology facility at the Tajiguas Landfill.

7. Criteria Workshops (if directed)

a. CONTRACTOR will organize and hold two workshops in Santa Barbara on the criteria to be used to evaluate responses to the Request for Proposals.

4. Exhibit B Payment Arrangements (Paragraph A) is hereby amended to read:

A. For CONTRACTOR services to be rendered under this contract, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed **\$182,500.**

All other terms and conditions of the agreement will remain in full force and effect. This amendment is effective on _____, 2009.
