### **Recommendation(s):**

That the Board of Supervisors:

- 1. Approve and execute a contract in the amount of \$110,300, with Kellee Clougherty, M.D., a local vendor, to provide psychiatric services to mentally ill and emotionally disturbed clients in Santa Barbara County ADMHS clinics. The contract term is from July 1, 2005, through June 30, 2006.
- 2. Approve and execute a contract in the amount of \$105,700, with Bob Black, M.D., a local vendor, to provide psychiatric services to mentally ill and emotionally disturbed clients in Santa Barbara County ADMHS clinics. The contract term is from July 1, 2005, through June 30, 2006.
- 3. Approve and execute a contract in the amount of \$110,300, with David K. Fennell, M.D., a local vendor, to provide psychiatric services to mentally ill and emotionally disturbed clients in Santa Barbara County ADMHS clinics. The contract term is from July 1, 2005, through June 30, 2006.
- 4. Approve and execute a contract in the amount of \$213,000, with Edwin Feliciano, M.D., a local vendor, to provide psychiatric services to mentally ill and emotionally disturbed clients in Santa Barbara County ADMHS clinics. The contract term is from July 1, 2005, through June 30, 2006.
- 5. Approve and execute a contract in the amount of \$41,700, with John Scott, a local vendor, to provide rehabilitation services to seriously mentally ill adults in the Santa Barbara County Psychiatric Health Facility (PHF). The contract term is from July 1, 2005, through June 30, 2006.

6. Authorize the Director of ADMHS to approve amendments to the proposed contract, provided that any such amendments do not exceed ten percent (10%) of the contract's dollar amount.

## Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work and Visit.

## **Executive Summary and Discussion:**

Kellee Clougherty, M.D., Bob Black, M.D., Edwin Feliciano, M.D., and David K. Fennell, M.D., are part of a group of Contractor-On-Payroll psychiatrists providing staffing to the Calle Real, Lompoc, and Santa Maria Clinics in Santa Barbara County. The doctors will perform diagnostic, medication, and involuntary admission evaluations, prescribe and administer medication, and provide training, education and support to ADMHS staff and/or Multi-Disciplinary Team members as needed. Each of the doctors will work between 20 and 40 hours per week in the clinics to which they are assigned.

John Scott is a rehabilitation (Rehab) specialist working in the Santa Barbara PHF. Mr. Scott provides Rehab services to seriously mentally ill adults in an effort to assist their re-entry into the community. These Rehab services include assisting with daily living skills, assessment and evaluation of progress, and the development of an intervention plan based on the occupational therapy evaluation.

Your Board is now requested to approve the Kellee Clougherty, M.D., Bob Black, M.D., Edwin Feliciano, M.D., David K. Fennell, M.D., and John Scott contracts. Approval of these contracts will allow ADMHS to continue to provide mandated psychiatric services throughout the county and rehab services in the PHF.

#### **Outcomes**

These physicians' contracts will help ADMHS meet **Recurring Performance Measures 0214 and 0215**, to provide effective mental health care to 2,450 emotionally disturbed children and 4,200 adults receiving mental health services. It is anticipated each of the doctors will perform 10-30 medical evaluations per week over the course of the year.

John Scott's contract will help ADMHS meet **Recurring Performance Measure 0219**, providing 950 hospital bed days in the PHF per month for individuals in acute crisis.

#### **Mandates and Service Levels:**

Mental Health Services are mandated by the Welfare and Institutions Code, Section 5600.

### **Fiscal and Facilities Impacts:**

These contracts are funded by Medi-Cal, EPSDT, and Realignment. These funding sources are identified in the Proposed FY 2005-06 Budget, Federal and State Funding, Medi-Cal line item 5405; and, Realignment funds line items 4102; in the Children's Services Division, County Budget Book, page D-156, and in the Adult Services Division page D-150.

These actions will not result in a need for any additional facilities.
