

**FOURTH AMENDMENT FOR FY 2009-10 TO THE
ANIMAL CONTROL SERVICES AGREEMENT
BETWEEN THE COUNTY OF SANTA BARBARA
AND THE CITY OF GUADALUPE FOR THE
REGULATION, CONTROL, AND ENFORCEMENT
OF ANIMAL CONTROL ORDINANCES WITHIN
THE CITY OF GUADALUPE**

THIS IS THE FOURTH AMENDMENT TO THE AGREEMENT (hereafter **Amendment Four**) to the Agreement for Animal Control Services, July 1, 2005, (hereafter **Contract**), made by and between the **County of Santa Barbara**, a political subdivision of the State of California (hereafter **County**), and **City of Guadalupe** (hereafter **City**).

WHEREAS, the parties desire to amend the Contract to extend the term of the Contract and to adjust the compensation payable to County for services performed under the Contract; and

WHEREAS, this Amendment Four incorporates the terms and conditions set forth in the Contract, the First, Second and Third Amendments, except as modified by this Amendment Four.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, **County** and **City** enter into this Amendment Four on July 1, 2009, and hereby agree to amend the Contract as follows:

Section 1:

Paragraph III: Service Charges to City is amended to read in its entirety:

Paragraph III: SERVICE CHARGES TO CITY

Between July 1, ~~2008~~ **2009** and June 30, ~~2009~~ **2010**, **City** shall pay **County** ~~\$37,998~~ **\$39,900** for those animal control services rendered under this Agreement to the **City** from the **County** operated shelter in Santa Maria. Reimbursement for services rendered will be paid within thirty (30) days of receipt of invoice.

Section 2:

Paragraph IX. Term of Agreement is amended to read in its entirety:

Paragraph IX. TERM OF AGREEMENT

The term of this Agreement shall be effective on July 1, ~~2008~~ **2009** and end on June 30, ~~2009~~ **2010**. The **County** shall notify the **City** prior to the end if the Agreement term of their intent to negotiate in good faith to reach agreement prior to the end of the Agreement term.

Section 3: Relationship of Amendment(s) to Original Contract

All the provisions of the Contract shall continue in effect except as modified by this Amendment Four.

Section 4:

In the event of any conflict or inconsistency between the provisions of this Amendment Four and the original Contract, including any amendments thereto, the provisions of this Amendment Four shall control in all respects.
