# **Recommended Actions:**

That the Board of Supervisors:

a. Authorize the Chief Probation Officer to accept the American Recovery and Reinvestment Act (ARRA) Byrne Memorial Competitive Grant Program award in the amount of \$1,005,334 for Fiscal Years (FY) 2009-2010 and FY 2010-2011.

#### **Summary Text:**

The Department has been awarded \$1,005,334 in competitive grant funding allocated by the Office of Justice Programs (OJP) under the Bureau of Justice Assistance (BJA) ARRA Edward Byrne Memorial Competitive Grant Program. The Probation Department was a Category Two applicant: "Providing for Funding of Neighborhood Probation and Parole Officers" and proposes to implement the Targeted Gang Intervention Program. The grant funding will facilitate the development of specialized caseloads for enhanced supervision of adult and juvenile probationers identified as gang members, associates, or affiliates, and assessed at a high level of risk to re-offend. The program will reinstate 3.0 FTE Deputy Probation Officer Senior (DPO Sr.) positions and a .5 FTE Administrative Office Professional position displaced due to FY 2008-09 midyear budget reductions. Additionally, to enhance supervision efforts

for those adult probationers at greatest risk to engage in violent crime, the grant funding will be used to provide second year funding (FY 2010-11) for a 1.0 FTE DPO Sr. position assigned to the Enhanced Electronic Supervision (EES)/Global Position System (GPS) program that is funded in the current FY through a separate ARRA grant allocation. The grant also provides funding for the Santa Barbara, Santa Maria and Lompoc Police Departments to respond to after hours GPS alerts.

The assigned DPO Srs. will be deployed in all three geographic regions of the County to supervise a hybrid caseload of juveniles and adults with gang-related terms and conditions and/or identified gang affiliations, and assessed at a high level of risk to re-offend. The DPO Srs. will work in collaboration with local law enforcement to enhance the supervision of high risk clients and promote a higher degree of community safety. Program participants will be engaged in their rehabilitation utilizing a cognitive behavior treatment model approach to encourage behavior modification, through programs such as Stanton Samenow's "Thinking Errors," as well as the Aggression Replacement Training (ART®) program. Evidenced based interventions will provide the targeted population of participants with alternatives and strategies to encourage a modification of their behavior to enhance the likelihood of success in the completion of probation terms and thereby reduce the need for local incarceration/detention and ultimately Department of Juvenile Justice or prison commitments.

# **Background:**

On February 17, 2009, President Obama signed the American Recovery and Reinvestment Act (Public Law 111-5, or "ARRA") with the intended purpose of creating/maintaining jobs and reenergizing the economy. As part of the package, ARRA includes funding to various federal agencies for a multitude of federal programs. The Office of Justice Programs, Bureau of Justice Assistance, through the ARRA Edward Byrne Memorial Competitive Grant Program helps communities improve the capacity of state and local justice systems and provide for national support efforts including training and technical assistance programs strategically targeted to address local needs. One of the focuses of this competitive grant is to provide funding for neighborhood-based probation and parole officers. It is recognized that community corrections professionals play a key role in both aiding prisoner reentry and preventing crime by monitoring and engaging adult and juvenile offenders in effective case management and offender supervision. Probation officers help jurisdictions "manage down" incarceration costs by allowing for the release of non-violent offenders earlier into the community, thus helping relieve the burden on stretched state and local budgets.

An outline of the proposed plan, previously submitted to the Economic Recovery Team, is attached. The focus of this program is to address the increase in gang-related crimes occurring throughout the county and to provide interventions which will assist in reducing these offenders' risk of continuing to engage in violent behavior. The objectives are consistent with the grant guidelines as well as local efforts to reduce gang violence, jail overcrowding and juvenile hall bed day use, as well as providing enhanced community resources to reduce prison commitments.

#### **Performance Measure:**

Ensure that 75% of offenders on Gang Intervention caseloads will successfully exit the program.

## Narrative:

The grant is a two year grant. FY 2009-10 grant funded expenditures total \$423,537 of which \$29,561 will be passed through to the cities of Santa Barbara, Lompoc, and Santa Maria to respond to after hours GPS alerts. The grant will result in the reinstatement of 3 DPO Srs. and a 0.5 Admin Office Professional that were displaced due to FY 2008-09 mid-year reductions. The FY 2010-11 revenue and expenditures related to this program will be included in the Department's FY 2010-11 proposed budget. The increase in FY 2010-11 is the result of the addition of second year funding for a GPS program funded in FY2009-10 by alternative ARRA funds. \$29,562 of the FY 2010-11 revenue will be passed through to the cities of Santa Barbara, Lompoc and Santa Maria to respond to after hours GPS alerts. There is no match requirement, the grant fully funds the program, and the Probation Department's general fund contribution will not change.



# Public Safety Edward Byrne Memorial Competitive Grant Program

#### SUMMARY/PURPOSE OF THE PROGRAM:

The Edward Byrne Memorial Competitive Grant Program applicants are limited to national, regional, state, or local public and private entities, including for-profit (commercial) and nonprofit organizations, faith-based and community organizations, institutions of higher education, tribal entities, and units of local government that support initiatives to improve the function of the criminal justice system and provide assistance to victims of crime (other than compensation).

The competitive grant announcement focuses on initiatives in eight areas: 1) preventing and reducing violent crime through community-based data-driven approaches; 2) providing funding for neighborhood-based probation and parole officers; 3) reducing mortgage fraud and crime related to vacant properties; 4) hiring of civilian support personnel in law enforcement (training staff, analysts, dispatchers, etc.); 5) enhancing forensic and crime scene investigations; 6) improving resources and services for victims of crime; 7) supporting problem-solving courts; and 8) national training and technical assistance partnerships.

#### PAST USE OF FUNDS:

This is a request for a new program. Funds have not been previously utilized.

#### PROPOSED USE:

The Probation Department will be applying under Category II: Providing for funding of neighborhood Probation and Parole officers. The Probation Department would reinstate three Senior Deputy Probation Officers displaced due to FY2008-09 midyear budget reductions who would be deployed in all three geographic regions of the county to supervise a hybrid caseload of juveniles and adults with gang-related terms and conditions and/or identified gang affiliations. The Senior DPOs would work in collaboration with local law enforcement which would allow for closer supervision of and enhanced services for high risk clients and result in a higher degree of safety within the community. The program would involve a cognitive behavior therapy approach in order to encourage behavior modification, and would utilize the Stanton Samenow "Thinking Errors" curriculum, as well as the Aggression Replacement Therapy (ART) program. The program would also provide for the use of GPS to track high risk offenders in the community.


# **PROPOSED BENEFITS:**

High risk adults, juveniles and transitional youth probationers would be supervised at a more intensive level, and will be provided with tools to encourage a modification of their behavior, resulting in a greater degree of community safety, and a higher degree of success in the completion of probation terms.

**Jobs Created/Maintained:** This program would reinstate three Senior DPOs, and a half time Administrative Office Professional to the Probation Department and provided funding for local law enforcement officers.

TOTAL FUNDING AVAILABLE: \$225M competitive through Recovery Act funds

#### **COUNTY ESTIMATED FUNDING:**

The grant proposal would be requesting \$1,005,334 which would be expended over the two year funding period. Of this amount \$946,211 would go to the County.

## OTHER ENTITY(IES) WITHIN COUNTY ESTIMATED FUNDING:

\$59,123 of the total award would be passed through to the cities of Santa Barbara, Santa Maria, and Lompoc.

#### FUNDING METHODOLOGY/REQUIREMENTS:

This program is a competitive grant program. Applications must be submitted online through OJP's grants management system. Applications are due 8:00pm eastern time on April 27, 2009. Applications are required to contain 5 specific sections and are scored on a 100 point scale.

#### TIMING FOR USE OF FUNDS:

The project period for awards under this program is up to 24 months. The project start date should be on or after July 31, 2009.
