Delete: 1.0 FTE Electronic Data Processing Office Automation Coordinator, Senior (Class 2481), Range 5910 (\$4,624-\$5,645 per month);

Add: 1.0 FTE Electronic Data Processing Systems and Programming Analyst I/II (Classes 2550/2553), Ranges (5890/6090) (\$4,578-\$5,589/\$5,058-\$6,175 per month).
