That the Board of Directors:

Approve and authorize the Chair to execute Amendment No. 1 to the Agreement for Trucking Services with RLF Trucking, a local vendor located on Alamo Pintado Road in Solvang, to increase the contract \$500,000 to not to exceed \$800,000 for the period through June 30, 2005 to clean out flood control facilities in response to the 2005 Storm.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendations are primarily aligned with Goal No. 2. Ensure the Public Health and Safety and Provide Essential Infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

On June 24, 2003, your Board entered into a two-year agreement with RLF Trucking to provide trucking services to haul material on as on needed bases to assist the Flood Control District's routine maintenance program as well as assist in emergency response efforts.

The Flood Control District is currently responding to the effects of the recent federally declared emergency. Our current priority is to repair damage on flood control facilities as well as clean out debris from basins and creeks that overflowed or need to be cleaned out to function properly. This amendment will allow the District to continue to clean out our facilities through the end of the June. The amount of the increase is substantial enough to allow the District to be prepared if rain continues and more clean out work is needed.

MANDATES & SERVICE LEVELS:

This amendment will allow the District to continue to clean out flood control facilities as needed. Cleaning out flood control facilities is critical to maintain service levels. If theses facilities are not cleaned out after debris build up, and rain continues, the potential for flooding is great.

FACILITIES AND FISCAL IMPACT:

Routine maintenance costs associated with this agreement were included in the 2004/05 Adopted Budget and were allocated in the Maintenance Cost Center under the Water Resources Division of the Public Works Department as shown on page D-326 in the budget book. A budget revision was submitted to cover costs associated with emergency response operations which includes costs associated with this agreement. These costs will be paid from Dept: 054, Fund: 2610, Acct: 7701/7703, Program: 3002.
