Mitigates Object Level overage issues in Services and Supplies identified with the Animal Services budget submittal in the amount of \$90,700. Animal Justification:

Services is experiencing an unusually high level of vacancies, some of which are positions funded by the Master Tobacco Settlement (or "TSAC"). This revision redirects the unused TSAC which funds these positions -either fully or in part- to be used for identified overages in required animal care expenses (food and medical care), staff safety and compliance, and training for new staff. In addition, the vacancies have required the redirection of IT and Fiscal

resources from other areas in the Public Health Department to ensure that Animal Services staff have adequate administrative support.

Justification: It is necessary to increase appropriations for a contract with the Los Olivos Community Services District for Phase 1 of a Wastewater Collection, Treatment

and Reclamation Project.

The total professional services contract will be \$180,000 of which \$150,000 is planned for FY 2019-2020. The current year budget includes \$30,000 and this budget revision request increases by \$120,000. Funding is available through a designation from the State Water Resources Control Board (SWRCB). SWRCB allows the Public Health Department to be reimbursed administrative overhead costs of \$12,120.
