Recommended Actions:

That the Board of Supervisors approve an amendment to the contract with Mental Health Systems, Inc. (a local vendor) increasing the contract by \$32,000 for a total contract not to exceed \$342,880 through June 30, 2012.

Summary Text:

Approval of the recommended action will allocate funding to allow Mental Health Systems, Inc. to provide alcohol and other drug (AOD) treatment services to residents of Santa Barbara County.

Background:

Mental Health Systems, Inc. (Mental Health Systems) provides alcohol and drug treatment services including outpatient individual and group counseling and drug testing in Santa Maria. Mental Health Systems also provides services to Substance Abuse Treatment Court (SATC) participants through the Methamphetamine Recovery Services Program funded by a grant from the federal Substance Abuse and Mental Health Services Administration (SAMHSA) and offers peer supported self-help groups to clients who are waiting to enter treatment programs. Mental Health Systems will provide treatment services to approximately 250 clients in FY 11-12.

MHS' original allocation for FY 11-12 included a significant reduction from prior year due to the MARS grant coming to an end. Approval of the recommended action will enable some services to

continue to be provided through the end of FY 11-12 to individuals with alcohol and other drug abuse issues.

Performance Measure:

Approval of the recommended action will help ADMHS meet the following Recurring Performance Measure:

To improve the quality of life for members of the community who abuse alcohol and drugs, the department will provide alcohol and other drug treatment services to approximately 4,261 clients (adults and youth) annually.

In addition, specific outcome measures for the service contract with Mental Health Systems, Inc. were included as Exhibit E in the original contract.
