Coastal Commission: Oil & Gas Consolidation Policies and Regulations

Recommendation: That the Board of Supervisors:

Adopt the attached Resolution, thereby directing staff to submit Local Coastal Program amendments to update policies and ordinances related to the consolidation of oil and gas facilities in the Coastal Zone (04GPA-00000-00018 and 04ORD-00000-00018) to the California Coastal Commission for certification.

Alignment with Board Strategic Plan: The recommendation is primarily aligned with actions required by law or by routine business necessity.

Executive Summary and Discussion: The cases referenced above amend the County's Local Coastal Program (LCP) and require certification by the California Coastal Commission. The amendments to the LCP are scheduled for approval by the Board of Supervisors at the March 21, 2006 hearing. Staff recommends that Board also approve the attached Resolution submitting the amendments to the California Coastal Commission.
