The Sheriff's Office has a newly created drone program under the Air Support Unit. Use of the drone program is outlined in Sheriff's Lexipol policy §603 – Unmanned Aerial System (UAS) Operations. The program currently does not possess any drones; therefore, the Brinc Lemur S would be the first UAS used by the Sheriff's Office in a specific law enforcement capacity. The Sheriff's Search & Rescue (SAR) team currently deploys several drones which are used for the search of missing persons. The SAR drones are limited to exterior use only.
