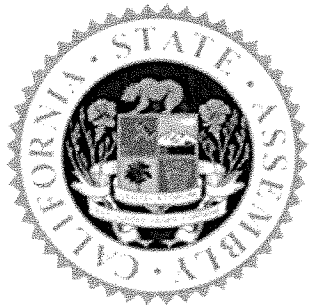

Dear Honorable Chair Williams and Board of Supervisors,

We write today to respectfully request that you either reject the request to file an exemption or postpone a decision to request an exemption from AB 1416-Ballot Disclose Act. The deadline to submit the exemption is 30 days before ballot comments are due.

By then, you will have a better understanding of how many measures will be on the ballot and be able to more precisely calculate the cost.

The value of having the major funders of the support and opposition campaigns for a measure on the ballot is tremendous. It can dramatically help level the playing field in terms of campaign spending.

We encourage you to embrace the spirit of this groundbreaking new law and keep the option to inform voters open while you gather more information.
