### **Recommendations:**

That the Board of Directors of the Santa Barbara County Flood Control and Water Conservation District accept fee ownership of Santa Barbara County Assessor parcel numbers 077-302-008, 077-305-002, & 077-331-023 (herein the "Parcels") by authorizing the Clerk of the Board to sign the Certificate of Acceptance attached hereto. (Clerk, Four-fifths vote required). The Parcels are located within the San Pedro Creek flood corridor near Covington Way in the City of Goleta, CA. Acceptance of the Grant Deed will transfer ownership of the Parcels from the County of Santa Barbara to the Santa Barbara County Flood Control And Water Conservation District, a special district (herein the "District"). The transfer will clarify ownership of the Parcels and will allow the District to continue its flood control and maintenance operations thereon.

### Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with actions required by law or by routine business necessity.

### **Executive Summary and Discussion:**

Montclair Enterprises granted the County fee ownership of the Parcels on July 2, 1962 via Subdivision Map Tract number 10,225. The Parcels were granted to the County for flood control purposes. The County accepted the Parcels on July 16, 1962 and the Tract Map recorded July 20, 1967 in Map Book 59, pages 1 through 7 in the office of the Santa Barbara County Recorder. The Santa Barbara County Flood Control And Water Conservation District has maintained the Parcels and the flood control infrastructure thereon since that time. The Parcels are located within the San Pedro Creek flood corridor near Covington Way within the newly incorporated City of Goleta. The transfer of ownership of the Parcels to the District will allow the District to continue its flood control and maintenance operations thereon.

## **Executive Summary and Discussion**: (Cont)

Most parcels owned by the County of Santa Barbara within the new City boundaries have been or are being transferred to the City. As these parcels owned by the County are for flood control purposes, they should be transferred to the Flood Control District.

The Boards of Supervisors' intention to execute the Grant Deed referenced above was made public in accordance with Government Code 25365.
