

**ORDINANCE AMENDING  
THE AGRICULTURAL COMMISSIONER'S FEE SCHEDULE**

**ORDINANCE NO. 12-\_\_\_\_\_**

**An ordinance of the County of Santa Barbara amending the existing Agricultural Commissioner's Fee Schedule to include established fees previously contained in County Code Chapter 34-C, Weights and Measures; to add new fees for the registration certificate requirements for point of sale systems and for packers; and to add a new California Department of Food and Agriculture administrative fee.**

**WHEREAS**, pursuant to Business and Professions Code §12103.5, the County Sealer is authorized to enforce and carry out the provisions of Division 5, Weights and Measures, of the Business and Professions Code; and

**WHEREAS**, pursuant to Business and Professions Code §12200, the County Sealer may appoint deputies or inspectors to carry out such duties; and

**WHEREAS**, pursuant to Business and Professions Code §12210, the County Sealer shall inspect, try, and test all weighing and measuring devices used for commercial purposes as defined in Business and Professions Code §12500(e); and

**WHEREAS**, pursuant to Business and Professions Code §12211, the County Sealer shall weigh or measure packages, containers, or amounts of commodities sold in order to determine whether they contain the quantity or amount represented and whether they are being sold in accordance with law; and

**WHEREAS**, pursuant to Business and Professions Code §13350, the County Sealer is authorized to determine the pricing accuracy of a retail establishment using a point-of-sale system if the Board of Supervisors has adopted or adopts an ordinance for those purposes; and

**WHEREAS**, pursuant to Business and Professions Codes §12240 and §13350, the Board of Supervisors, by ordinance, may charge an annual registration fee not to exceed the County's cost of performing such inspections, and

**WHEREAS**, pursuant to Business and Professions Codes §12241, the California Department of Food and Agriculture shall establish an annual administrative fee for costs associated with the activities performed pursuant to §12210 and §12211, and

**WHEREAS**, pursuant to Government Code §25102-§25132, the County has, in connection with the above fees, held a public hearing as part of a regularly scheduled meeting and published notice of the meeting, including a general description of the matter to be considered;

**NOW THEREFORE, THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA BARBARA ORDAINS AS FOLLOWS:**

That the fees notated as “amended” in the attached Fee Schedule are hereby adopted. Said fees are to be assessed against all persons required to have annual registration certificates for Weights and Measures and are to become effective May 10, 2012. The Weights and Measures fees established by Ordinance 4751 effective July 1, 2010 are hereby repealed on the above-mentioned date that the fees imposed by this Ordinance become effective. The repeal of the Weights and Measures fees imposed by Ordinance 4715 shall not affect any obligation to pay any fees incurred under said ordinance and said obligation shall continue in effect after said resolution is repealed, and the County of Santa Barbara may take any appropriate action in regard to any delinquent fees imposed pursuant to said ordinance.

Weights & Measures Device, Point of Sale System, Packer Registration, and California Department of Food and Agriculture administrative fees (amended)

I. The annual registration fee for a business that uses a commercial weighing or measuring device or devices shall be pursuant to Business and Professions Code section 12240 and shall consist of a business location fee, a device fee, and a Department of Food and Agriculture administrative fee as authorized by Business and Professions Code section 12241 and set forth in 4 CCR §4075. The business location fee and device fee shall be the following:

(a) A business location fee of one hundred dollars (\$100) per business location, plus the applicable device fee listed in subdivisions (b) to (i), inclusive.

(b) For marinas, mobile home parks, recreational vehicle parks, and apartment complexes, where the owner of the marina, park, or complex owns and is responsible for the utility meters, the device fee is (\$2) per device per space or apartment. Marinas, mobile home parks, recreational vehicle parks, and apartment complexes for which the above fees are assessed shall be inspected and tested as frequently as required by regulation.

(c) For weighing devices, other than livestock scales, with capacities of 10,000 pounds or greater, the device fee shall be two hundred fifty dollars (\$250) per device; for weighing devices, other than livestock scales, with capacities of at least 2,000 pounds but less than 10,000 pounds, the device fee shall be one hundred fifty dollars (\$150) per device.

(d) For livestock scales with capacities of 10,000 pounds or greater, the device fee shall be one hundred fifty dollars (\$150) per device; for livestock scales with capacities of at least 2,000 pounds but less than 10,000 pounds, the device fee shall be one hundred dollars (\$100) per device.

(e) Farm milk tanks are exempt from registration certificate requirements and all annual registration fees.

(f) A scale or device used in a certified farmers' market, as defined by Section 113745 of the Health and Safety Code, is not required to be registered in the county where the market is conducted, if the scale or device has an unexpired seal for the current year, issued by a licensed California county sealer. Any resident of Santa Barbara County that brings a scale or device used in a certified farmers' market to a location specified by the office of weights and measures for testing shall be exempt from paying a business location fee for that device.

(g) For liquefied petroleum gas (LPG) meters, truck mounted or stationary, the device fee shall be one hundred seventy-five dollars (\$175) per device.

(h) For wholesale and vehicle meters, the device fee shall be twenty-five dollars (\$25) per device.

(i) For all other commercial weighing or measuring devices not listed in subdivisions (b) to (h), inclusive, the device fee shall be twenty dollars (\$20) per device. For the purposes of this subdivision, the total annual registration fee shall not exceed the sum of one thousand dollars (\$1,000) for each business location.

II. The annual registration fee for each location with point of sale systems shall consist of a device fee with no location fee and no Department of Food and Agriculture administrative fee. Pursuant to Business and Professions Code section 13350, the following device registration fees shall apply except as specified in the Small Business Allowance section below:

Number of Point of Sale Stations	Annual Registration Fee
1-3	\$ 80.00 per location
4-9	\$160.00 per location
10 or more	\$240.00 per location

In addition, a fee for any reinspection as authorized by Business and Professions Code section 13350 shall be billed at the hourly rate for one inspector as set forth above.

Small Business Allowance. A business that meets all of the following conditions may remit one-half (forty dollars) the annual registration fee specified above:

1. The business has a single sales location in the county that has 1-3 point of sale stations;
2. The business has gross sales in the amount of \$200,000.00 or less for the latest year; and
3. The business verifies the qualifying gross sales by including a signed copy of their latest Internal Revenue Service tax filing for the qualifying business with their reduced payment.

III. As authorized by Business and Professions Code section 12240, the annual registration fee for a packer shall be as follows:

IV. As authorized by Business and Professions Code section 12241, and set forth in 4 CCR §4075, the California Department of Food and Agriculture administrative fee shall be as follows:
