**SUBJECT:** Installation of New Leach Field and Equipment Wash Down Station, Jalama Beach County Park; Project No. D24019; Third Supervisorial District

**Recommendation(s):**

That the Board of Supervisors authorize the Director of Parks to advertise for construction bids for the installation of a new leach field for the existing shower building and installation of an equipment wash down pad at Jalama Beach County Park; County Project No. D24019.

**Alignment with Board Strategic Plan:**

The recommendation is primarily aligned with Goal No. 5.A High Quality of Life for All Residents and with Goal No. 2. A Safe and Healthy Community in Which to Live, Work, and Visit.

**Executive Summary and Discussion:**

This project includes the installation of a new leach field system for the existing shower building at Jalama Beach County Park. The current leach field system is not large enough to handle the peak summer use of the shower building without extensive monitoring and maintenance efforts by Park staff. The project also includes the installation of a concrete wash pad for the washing of vehicles and equipment. The pad will collect runoff from the wash in a drop inlet constructed with a storm water interceptor designed to remove oil and grease from the water prior to discharging it into the storm drain system. Both of these projects are designed to reduce the potential of surface and subsurface contaminants reaching nearby Jalama Creek and thus improving ocean water quality in the area.

The "Notice to Contractors" will be published prior to the date set for the opening of bids. Sealed proposals to construct this project will be received at the County Parks Administration Office, 610 Mission Canyon Road, Santa Barbara, CA 93105 at a date to be determined and will be opened publicly and read aloud.
