Recommended Actions: That the Board of Supervisors:

- A. Approve and authorize the Chair to execute a contract with Community Action Commission to provide an Independent Living Program for Child Welfare Services/ Probation youth for the period of 7/1/07 through 6/30/08 at a cost not to exceed \$185,000.
- B. Authorize the Director of the Department of Social Services, at her discretion, to exercise the County's renewal option provided for in the contract, for a period not to exceed one year and a cost not to exceed \$203,500. Including the renewal period, if exercised, the total term of the contract would be for a maximum of two years with a cost not to exceed \$388,500.

Summary Text:

The Independent Living Program (ILP) goal is to enable youths, ages 16-21 to achieve self-sufficiency prior to leaving the foster care support system and through the continuum of emancipation. Academic Education and Life Skills preparation are the foundation of the program and the cornerstone of the Transitional Independent Living Plans developed to guide youth through to emancipation. The program encompasses emancipation preparation case management and learning activities in seven skill areas: Education, Employment, Daily Living Skills, Survival Skills, Choices and Consequences, Interpersonal/Social Skills, and Computer/Internet Skills to enhance the success of youth transitioning into self-sufficiency.

Social Services requests that your Board grant authorization for the Director of the Department of Social Services to exercise the renewal option contained within the contract for a period not to exceed one year.

The amount for the extension period would be between \$185,000 and not to exceed \$203,500. The highest figure is based on a ten percent increase in the annual contract cost. Should contract costs exceed this ceiling, Social Services would bring the matter before your Board before the renewal option could be exercised. The total contract amount for the initial contract period and the extension will not exceed \$388,500.

Background:

Santa Barbara County Department of Social Services is held accountable by the State to comply with the California Manual of Policy and Procedures Division 30 and 31 ILP regulations. These regulations necessitate ILP services to provide learning activities in the seven ILP skill areas: Education, Employment, Daily Living Skills, Survival Skills, Choices & Consequences, Interpersonal/Social Skills, and Computer/Internet Skills. In addition, the Santa Barbara County ILP includes an Aftercare Program designed to specifically meet the unique needs of youth ages 18 up to 21 who have emancipated from the foster care system. Services to be provided under this Agreement are in conformance with California Manual of Policy and Procedures Division 30 and 31 Regulations.
