 Title: Public Health Salary Savings transfer for one-time software replacement
 Budget Action: Transfer Appropriations of \$251,945 in the Public Health Department Health Care Fund from Salaries and Benefits to Services and Supplies (\$62,490) and Capital Assets (\$189,455) for the replacement of Public Health Laboratory Software.

Justification: This budget revision will transfer appropriations in the amount of \$251,945 from salary savings to services and supplies (\$62,490) and to capital assets (\$189,455) for the one-time costs of the replacement of Public Health Laboratory Software in the Public Health Department.
 The existing Public Health Laboratory software is no longer adequate for our business needs. After an extensive evaluation process, the Harvest product from Orchard Systems was chosen. This system is already in place in many of our peer counties.
 While the total costs of the project are estimated at \$399,000, the FY 14-15 costs of the system are projected at \$251,945: \$147,055 for the software, \$42,400 for hardware and servers, \$32,490 for computers and barcode scanners, and \$30,000 for other non-capital equipment, such as backup and communication hardware.
