On June 27, 2006, the Board of Supervisors executed a Professional Services Agreement for the Preparation of the Goleta Beach Long Term Protection Plan Environmental Impact Report (EIR) with Chambers Group, Inc.

The existing agreement with Chambers Group, Inc. requires that work be completed no later than December 31, 2007. Due to the time required to assist County Parks with the processing of a permit from the California Coastal Commission for the installation of the Permeable Pile Pier, and to assist

Amendment No. 2 was approved by the Board (July 17, 2007) to provide additional funds in the amount of \$60,000 to augment the original contract for professional services of \$310,000; bringing the total amount for this contract to a not to exceed amount of \$370,000.
