WHEREAS, the COUNTY executed an Agreement (AGREEMENT) between the County of Santa Barbara (COUNTY) and CUYAMA VALLEY RECREATION DISTRICT (OWNER), dated November 14, 2017, pursuant to the Community Development Block Grant program from the United States Department of Housing and Urban Development ("HUD") under Title I of the Housing and Community Development Act of 1974, as amended (HCD Act), Public Law 93-383 (42 U.S.C, §§ 5301 et seq.); and the regulations promulgated thereunder (24 CFR Part 570) ("Regulations"); and

Recitals

WHEREAS:

1. The County of Santa Barbara ("County") has received funds from the United States Department of Housing and Urban Development ("HUD") under the Community Development Block Grant program, hereafter referred to as CDBG, under Title I of the Housing and Community Development Act of 1974, as amended, for the purpose of supporting community development activities that benefit low and moderate income persons; and
2. On July 11, 2017 the County Board of Supervisors adopted and approved submittal to HUD of the Santa Barbara County CDBG Urban County 2017-2018 Action Plan which reserved CDBG funding in the amount of Three Hundred and Forty One Thousand Hundred Dollars (\$341,000), for the Cuyama Valley Recreation District Park Improvements (PROJECT) located in New Cuyama, California; and
3. On November 14, 2017, the parties entered into an Agreement to carry out the Project; and
4. Section II describes the Term of the Agreement as ending on September 30, 2018; and
5. On September 27, 2018, the parties entered into a First Amendment to extend the term of the Agreement to March 30, 2019; and
6. The Project is currently underway but will not be completed by March 30, 2019 and time is of the essence; and

7. The County and CUYAMA VALLEY RECREATION DISTRICT mutually agree to extend the Term of the Agreement.

NOW, THEREFORE, it is mutually agreed by County and CUYAMA VALLEY RECREATION DISTRICT to extend the Term of the Agreement to March 30, 2020.

Except as set forth hereof, this Amendment shall not modify or change any of the provisions of the Agreement and the parties to the Agreement are bound by its provisions, as amended herein.
