**Recommended Actions:**

That the Board of Supervisors set a hearing for the October 18, 2022 Board of Supervisors meeting to consider recommendations, as follows:

- a) Receive and file the annual TRUTH Act report regarding United States Immigration and Customs Enforcement (ICE) access to individuals as required by Government Code section 7283.1(d);
- b) Hold the public hearing, as required by Government Code section 7283.1(d), regarding ICE's access to individuals, and receive and consider public comment; and
- c) Determine pursuant to CEQA Guidelines 15378(b)(5) that the above actions are not a project subject to CEQA review, because it is a government administrative activity that does not result in direct or indirect physical changes to the environment.

**Summary Text:**

Government Code section 7283.1(d), of the Transparent Review of Unjust Transfers and Holds ("TRUTH Act"), requires the Board of Supervisors to hold at least one community forum annually, with at least 30 days of notice, "to provide information to the public about ICE's access to individuals and to receive and consider public comment."

**Background:**

As of January 1, 2018, Government Code section 7283.1(d) requires the Board of Supervisors to hold at least one community forum annually, with at least 30 days of notice. The purpose is “to provide information to the public about ICE’s access to individuals and to receive and consider public comment.” Notice of the October 18, 2022 community forum will be provided to the public through publication in two newspapers of general circulation. The public notices will be published at least 30 days in advance of the October 18, 2022 hearing in the Santa Barbara News Press and the Santa Maria Times.

Section 7283.1(d) also provides that the Sheriff’s Office “may provide the governing body with data it maintains regarding the number and demographic characteristics of individuals to whom the agency has provided ICE access, the date ICE access was provided, and whether the ICE access was provided through a hold, transfer, or notification request or through other means. Data may be provided in the form of statistics or, if statistics are not maintained, individual records, provided that personally identifiable information shall be redacted.” As a part of the community forum, the Sheriff’s Office will present relevant data.

## **Custody Operations Policy 210. Truth Act (ICE)**

**PURPOSE:** To set guidelines for compliance with Assembly Bill No. 2792, the Truth Act, effective January 1, 2017 within County Sheriff's Office jail facilities and for those persons having legitimate business within the Custody Operations branch.

**POLICY:** The Santa Barbara County Sheriff's Office prohibits discrimination against persons due to immigration status. The Santa Barbara County Sheriff's Office adheres to applicable federal and state laws, regulations and guidelines by providing notification to inmates of communication between the Department of Homeland Security, Immigration and Customs Enforcement (ICE) and County Jail staff for the purpose of deportation and/or detention by ICE agents upon completion of commitments of incarceration.

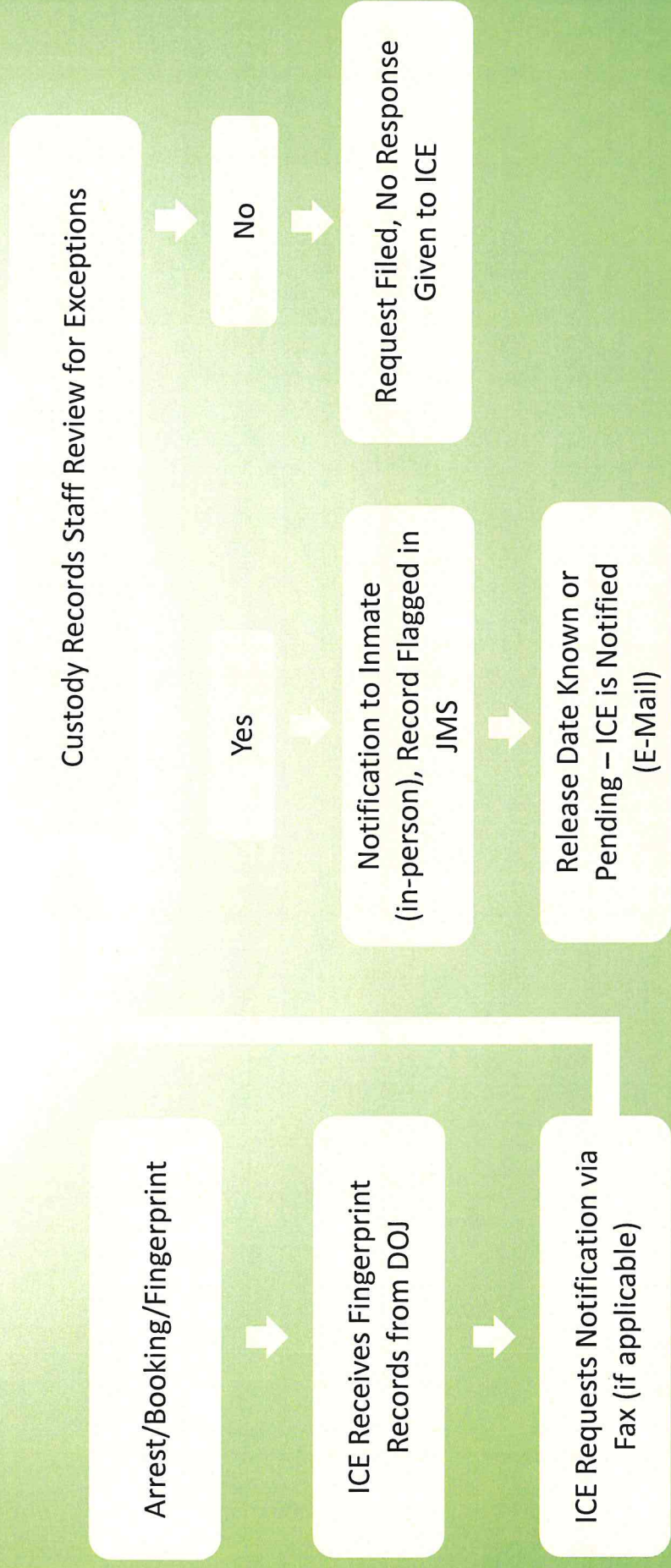

## ICE ACCESS INFORMATION - 2021

- *Note on Data Collection:* Historically, the Sheriff's Office has not maintained public records on aggregate ICE "access" data. All data provided herein resulted from manual staff research on individual booking packets.
- In 2018, the Values Act (SB 54) became law and changed certain aspects of the Truth Act.

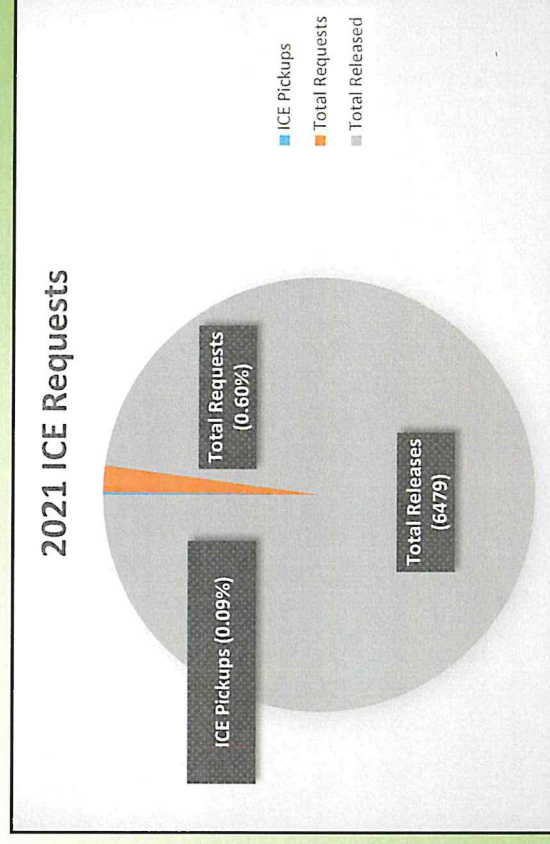
## ICE NOTIFICATION PROCESS

From 2020 to 2021, the number of ICE Requests decreased, additionally, the number of ICE re-arrests decreased over 68%.
