- b) Approve the Final Mitigated Negative Declaration and adopt the mitigation monitoring program pursuant to the County's California Environmental Quality Act (CEQA) guidelines for the Burton Mesa Public Safety Center project; and
- Authorize the Director of General Services to advertise for construction bids for Burton Mesa c) Public Safety Center project.

Summary:

This project will construct a 12,581 square foot combined use Fire and Sheriff Operations facility, which will replace the existing Fire Station 51 and the Burton Mesa Sheriff Sub-Station. The total project budget is \$5,215,000 and is being funded by previously authorized Certificate of Participation financing.

Background:

The County purchased a 15.35 acre parcel of surplus state land to be the new location for Fire Station 51. The parcel is located at the corner of Burton Mesa Blvd. and Harris Grade Road. A Draft Mitigated Negative

Declaration was circulated for public review on March 21, 2006 to address the environmental impacts of the project. After receiving public comments, a Final Mitigated Negative Declaration was compiled incorporating all public comments. A final Mitigated Negative Declaration was approved by the Planning and Development Department on November 16, 2006. Mitigation requirement is primarily the replacement of chaparral lost from the construction footprint.

The new structure will be approximately 11,358 square feet with two apparatus bays (12,581 SF including a 3 apparatus bay add alternate option). The Fire Department will occupy approximately 6,738 square feet with two bays or 7,961 square feet with the alternate third bay option and the Sheriff's Department will occupy approximately 3,631 square feet. There is an additional 989 square feet of shared common space. This new structure will encompass apparatus bays, living quarters to accommodate eight on-duty firefighters, Sheriffs operations offices, a conference / training room, and a work-out room.

Fire Station 51 supports structural and wild land firefighting operations, paramedic transport services, and reserve firefighter operations. Sheriff's patrol operations for the Lompoc Valley are supported by this facility.

Performance Measures:

Fiscal and Facilities Impacts:

The new Burton Mesa Public Safety Center will replace the deteriorating existing Fire Station 51 facility and provide a more prominent and responsive location for public safety operations in the Lompoc Valley.

With approval of the recommended actions, General Services anticipates that the construction contract can be awarded in late March 2007. Occupancy of the new facility would then likely occur in January 2008.
