Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

The County has designed the plans and specifications to install and construct new sidewalk improvements on a number of more heavily traveled streets and intersections in Isla Vista in connection with the Isla Vista Sidewalk Project. With this phase of the project, approximately 340 linear feet of sidewalk, 490 linear feet of sidewalk with retaining curb, 120 linear feet of curb and gutter and six curb ramps were installed. This work completes Phase III of this installation.

This sidewalk improvement project was approved in the FY 01/02 Capital Improvement Plan. Your Board entered into a contract on July 15, 2003, for the amount of \$92,159.10, including contingency. On September 19, 2003, your board approved Contract Change Order Number One to extend the scope of the project to include the south side of Cordoba Road which is a priority as well. This Change Order resulted in a total contract amount of \$105,487.70.

The project was bid in accordance with the Public Contract Code, which requires the Department to award to the lowest responsible bidder.
