THIS EXERCISE OF OPTION TO EXTEND THE TERM of the Emergency and Non-Emergency Ambulance Service Agreement for Advance Life Support and Pre-Hospital Care (hereafter Agreement), is entered into by and between the County of Santa Barbara (COUNTY) and American Medical Response West (CONTRACTOR), to provide for the continuation of services by CONTRACTOR.

WHEREAS, Section 1.4 of the Agreement provides that the "Agreement may be extended for two (2) subsequent three-year terms" and that "two years prior to the expiration of this Agreement, CONTRACTOR shall petition the EMS Agency Director for the option to extend the Agreement"; and

WHEREAS, CONTRACTOR has met, and exceeded, all conditions for Agreement extension as outlined in Section 1.4 of the Agreement; and

WHEREAS, both parties desire to extend the term of the Agreement using the second of the "two (2) subsequent three-year terms" options to renew.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

1. <u>Definitions.</u> Capitalized terms used in this Exercise of Option to Extend Term, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.

2. Amendments.

a. The Agreement shall be amended as follows:

SECTION 1 – ADMINISTRATION OF THE CONTRACT AND TERMS

1.2 Term of Contract

The term of this Agreement shall commence at 00:01 hours on January 1, 2005 (Effective Date), and shall terminate at midnight on December 31, 2014 2017, unless terminated earlier pursuant to the terms and conditions of this Agreement.

3. <u>Counterparts.</u> This Exercise of Option to Extend Term may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
