

# AMENDMENT NO. 1 TO THE AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR WITH Enviroscaping, Inc. for Maintenance of Revegetation Sites for the Santa Maria River Realignment Project (Project No. 23GU01)

(BC No. 23-218)

Pursuant to Paragraph 30 of the Agreement for Services of Independent Contractor (hereinafter AGREEMENT) entered into on December 12, 2023, as BC No. 23-218 between the Santa Barbara County Flood Control and Water Conservation District (hereafter COUNTY), and Enviroscaping, Inc. having its principal place of business 340 Pine Avenue, Goleta, CA 93117 (hereinafter CONTRACTOR), the COUNTY and CONTRACTOR amend the AGREEMENT as follows:

## 1. Paragraph 4 (TERM) of the AGREEMENT is hereby amended to read:

CONTRACTOR shall commence performance on December 12, 2023 and end performance upon completion, but no later than December 31, 2024 unless otherwise directed by COUNTY or unless terminated earlier.

# 2. Attachment B1 of the AGREEMENT is hereby amendment to read:

Rates:

Hourly Rate for construction/construction maint Laborer: \$154.00 per hour

Hourly Rate for Supervisor for construction/construction maintenance: \$154.00 per hour

Hourly Rate for landscape maintenance: \$41.00 per hour

Haul Trucks: \$135.00 per day

Skid Steer: \$400.00 per day

Utility vehicle (4X4): \$400.00 per day

Maintenance labor rates may be implemented 90 days after completion of installation. If heavy equipment work is mobilized then construction rates would be implemented.

Estimated total per month \$45,000.00

Fiscal Year 2023-2024:

For the period through December 2024

6 months anticipated full-time:

\$270,000.00

In all other respects, the AGREEMENT remains unchanged and in full effect.
