Recommended Actions:

That the Board of Supervisors consider the following:

- a) Approve and authorize the Chair to execute the Student Support Agreement between Santa Barbara County and California State University, Long Beach for the period of five (5) years, terminating on September 30, 2028; and
- b) Approve and authorize the Public Health Director to make immaterial amendments to the Agreement with California State University Long Beach in accordance with Agreement section 22, upon review and concurrence by County Counsel's Office through September 30, 2028; and
- c) Determine that the proposed actions do not constitute a "Project" within the meaning of California Environmental Quality Act (CEQA), pursuant to section 15378(b)(5) because the actions are organization and administrative activities of the government that will not result in direct or indirect physical changes in the environment.

Summary Text: This item is on the agenda to approve and authorize the Chair to execute a Student Support Agreement between Santa Barbara County and California State University Long Beach (CSULB). CSULB currently has a Didactic Program in Dietetics where students need 200 hours of supervised internship. The Board approved the Public Health Department Student Support Agreement (SSA) template on January 14, 2020 and is requested to approve a new five-year agreement with termination on September 30, 2028. The SSA with CSULB deviates from the approved template terms

and conditions as follows: removes reference to student in the indemnification section and adds that students are not entitled to benefits related to employment from either the County or CSULB.

Background:

The Student Support Agreement template that was approved by the Board in 2020 included a requirement that educational institutions would be responsible for providing all legally-required benefits to the students and responsible for providing damages caused by negligence of CSULB's students. However, CSULB, as an organization, does not provide benefits to students and does not accept liability for its students. In order to address this concern, the student(s) will sign the County's Student Waiver and Release Agreement (Exhibit B) releasing the County from and against any and all liability arising from the student(s) participation in the internship program.

The benefits of moving forward with this risk are allowing students from the CSULB Didactic Program in Dietetics to complete their internship hours with the Public Health Department (PHD). These interns will be closely supervised and provide a low risk for the County of Santa Barbara. The PHD will benefit from interns through learning about fresh, new ideas that are happening in the field of Dietetics, and potentially be able to recruit interns to becoming PHD or County of Santa Barbara employees and allow those students who are a part of our community to learn more about the PHD and County of Santa Barbara mission and work.

Santa Barbara County Risk Management has also reviewed and suggested changes to the indemnification and legally-required benefit provisions for this agreement based on the response from CSULB.

The Student Support Agreement will be a five-year agreement with termination on September 30, 2028. There is no compensation associated with this Student Support Agreement.
