- A. On December 20, 1980, by Resolution No. 80-566, the Board of Supervisors of the County of Santa Barbara adopted the Comprehensive Plan for the County of Santa Barbara; and
- B. On February 8, 1994, By Resolution 94-96, the Board of Supervisors adopted the Los Alamos Community Plan as part of the Santa Barbara County Comprehensive Plan; and
- C. On October 17, 2006, by Ordinance No. 4265, the County Board of Supervisors adopted Section 35-1, the Santa Barbara County Land Use and Development Code (LUDC), of Chapter 35, Zoning, of the Santa Barbara County Code, to implement the Comprehensive Plan; and
- D. In August 2006, the Board of Supervisors established the Los Alamos Planning Advisory Committee (LAPAC) to assist staff in updating the Los Alamos Community Plan. The LAPAC's role included gathering public input, participating in the goal setting process, and developing recommendations on the land uses, policies and programs developed in the draft Los Alamos Community Plan; and
- E. Public officials and agencies, civic organizations, and citizens have been consulted on and have advised the Planning Commission on the proposed amendments in a duly noticed public hearing; and
- F. It is now deemed in the interest of orderly development of the County and important to the preservation of health, safety, and general welfare of the residents of said County that the Planning Commission recommend that the County Board of Supervisors initiate, for

WHEREAS, in February 1994, the Board of Supervisors adopted the Los Alamos Community Plan (hereinafter "Plan") to amend the Comprehensive Plan with policies, standards, and implementation measures within the Los Alamos Community Plan Area (hereinafter "LACP Area"); and,

WHEREAS, the Plan has been scheduled for an update through a community planning process to reflect changes in the community since the adoption of the Plan; and,

WHEREAS, in August 2006, the Board of Supervisors established the Los Alamos Planning Advisory Committee (LAPAC) to assist staff in the Los Alamos Community Plan update. The LAPAC's role included gathering public input, participating in the goal setting process, and developing recommendations on the land use, policies and programs developed in the draft Plan; and,

WHEREAS, historically, the Planning and Development Department has suspended the processing of rezone and/or comprehensive plan amendment applications within a planning area boundary while a community plan is prepared, unless the Planning Commission determines a project to be a significant public benefit or a rezone that is consistent with the Comprehensive Plan.

WHEREAS, it is in the interest of the County to continue processing comprehensive plan amendment and rezone applications that have been accepted for processing by the Planning and Development Department.

NOW, THEREFORE, IT IS HEREBY RESOLVED AS FOLLOWS:

- 1. The above recitation is true and correct.
- 2. The County shall:
 - a. Suspend rezones and comprehensive plan amendments within the LACP Area until the Board of Supervisors adopts the Plan, unless the Planning Commission determines a project to be a public purpose.
 - b. Allow rezone applications which are consistent with the Comprehensive Plan to be considered.
