That the Board of Supervisors:

- a) Approve, ratify, and authorize the Director of the Public Health Department, or designee, to accept a grant award for the Santa Barbara County Public Health Department in the amount of \$10,000 from the Santa Barbara Foundation as well as execute the accompanying Educational Grant Services Agreement for the period of August 1, 2024, through June 30, 2025 for the purpose of providing planned education sessions throughout Santa Barbara County for health professionals and community members; and
- b) Approve the Budget Revision Request (BJE Number 0010141) in the amount of \$10,000 for unanticipated revenue for use in the Public Health Department FY 2024-25 budget; and
- c) Determine that the proposed action is an administrative and fiscal activity of the County, which will not result in direct or indirect physical changes in the environment; and is therefore, not a "project" as defined for purposes of the California Environmental Quality Act (CEQA), pursuant to State CEQA Guidelines Section 15378(b)(4) or (b)(5).

sessions throughout Santa Barbara County for health professionals and community members in the county. These grant funds will be used to cover expenses such as speaker fees including travel and accommodation, audio visual and media setup, education and wellness promotional material, and other related miscellaneous costs as needed.

Background:

The Santa Barbara Foundation and the Public Health Department (PHD) in collaboration with community partners will coordinate and provide a minimum of four activities that educate health professionals and community members about health and wellness. The PHD has recently established a special program with focus on equity, prevention, and wellness promotion. This program will involve more community events geared towards partnering with health systems, educational entities, and community organizations to promote wellness and healthy living. These educational activities are designed and opened for public healthcare professionals and county team members to advance their understanding of pertinent and important health matters.

PHD will seek to collaborate with community partners to hold educational sessions (lectures) at strategic locations throughout the county (i.e. south, central, and north). Each event will accommodate between 80 to 100 attendees.

Topics for each educational activity will be based on needs identified through our community health needs assessment, data gathered from clinics, as well as feedback from health practitioners and other partners. In addition, a survey at each event will ask for consideration for future topics from attendees.
