### **Recommendation(s):**

That the Board of Directors of the Santa Barbara County Flood Control and Water Conservation District accept a <u>Quitclaim Deed</u> for real property (flood control basin) from Cal-Westgate Ranch, LLC, a California Limited Liability Company, owners of Santa Barbara County Assessor parcel No. 117-240-007 located near the City of Santa Maria, by authorizing the Clerk of the Board to sign the Certificate of Acceptance attached to the Quitclaim. Fifth District, Four-fifths vote required.

## Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with actions required by law or by routine business necessity.

### **Executive Summary and Discussion:**

On September 14, 1999 the Board of Directors of the Santa Barbara County Flood Control and Water Conservation District (herein the "District") executed a Certificate of Acceptance for the purchase of an easement covering most of APN 117-240-007 (the "Property"). The easement was purchased to allow for the construction and use of a retention basin near the intersection of Blosser & Stowell Roads. Subsequent to that purchase the "Hobbs Basin" has been constructed and is currently in use.

Cal-Westgate Ranch has no need for the fee interest in the land underlying the basin or the remainder of the Property and has offered to transfer fee ownership of the entire parcel to the District at no charge.
