SUBJECT: **No Parking Zone on North Jameson Lane; First Supervisorial District.**

RECOMMENDATIONS:

That the Board of Supervisors adopt a resolution establishing a “No Parking” zone on North Jameson Lane in the Montecito area.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

North Jameson Lane is a two lane major east-west arterial road paralleling the U.S. 101, in the Montecito area.

A number of complaints have been received requesting that a “No Parking” zone be established on the south side of North Jameson Lane, east of the U.S. 101 under crossing that serves Sheffield Drive. Based upon our investigation of this site, it was determined that creating a “No Parking” zone at this location (see vicinity map) would increase sight distance and improve public safety for those residing and traveling on North Jameson Lane. The Public Works Traffic Section has prepared the attached resolution to establish a “No Parking” zone at the following location:

On the south side of North Jameson Lane from the centerline of the U.S. 101 under crossing, to a point 154 feet east of the centerline of the U.S. 101 under crossing.
