Reasons to support exemption findings:

The adoption of thresholds of significance pursuant to CEQA Guidelines section 15064.7 is not itself a "project" requiring CEQA review, because the CEQA Guidelines, §15064.7, prescribe a process that public agencies must follow to adopt thresholds of significance, and prior CEQA review is not part of the process.

CEQA Guidelines, §15308 categorically exempts actions taken by regulatory agencies as authorized by state or local ordinance, to assure the maintenance, restoration, enhancement or protection of the environment where the regulatory process involves procedures for protection of the environment. Adoption of these thresholds establishes procedures that will protect cultural resources.

CEQA Guidelines, §15378(b) specifies that adoption of a regulation does not constitute a project. Adoption of these thresholds is the adoption of such a regulation.

The action to adopt thresholds does not have the potential to result in either a direct physical change in the environment, or a reasonably foreseeable indirect physical change in the environment. The adoption of this threshold is not related to any particular development project and individual projects will be subject to compliance with CEQA, as applicable.
