**WHEREAS**, the portions of the PUE are proposed for vacation (collectively the "Portion") are located within Tract Map No. 10,036 (herein the "Property"), which Portion is shown on Exhibit "A-1" attached hereto and incorporated herein by this reference; and

WHEREAS, on November 8, 2022, the owners of the Property submitted an application to the COUNTY to vacate the Portion; and

WHEREAS, the proposed PUE vacation would dispose of unneeded, excess areas of COUNTY Public Utilities Easements by permanently abandoning the COUNTY's easement interest in the Portion; and

WHEREAS, at its regular meeting of June 14, 2023, the COUNTY'S Planning Commission found the abandonment of the Portion to be in conformity with the COUNTY'S Comprehensive Plan pursuant to Government Code Section 65402(a); and

WHEREAS, in accordance with California Streets and Highways Code Section 8321 (e), 8322(a), and 8323, the COUNTY is required to reserve and except from the vacation of the Portion any easement and right necessary to maintain, operate, replace, remove, or renew any in-place public utility facilities that are in use; and

WHEREAS, no public utility providers have in-place and in-use public utilities in the area of the Portion; and

WHEREAS, it has been determined by the COUNTY'S Public Works Department that the Portion is unnecessary for present or future public use and is no longer required by the COUNTY; and

**WHEREAS**, in accordance with California Streets and Highways Code Section 8300 et seq, the legislative body of a local agency may summarily vacate a Public Utilities Easement, and the excess Portion meets this criteria; and


**NOW, THEREFORE, BE IT RESOLVED**, the Board of Supervisors of COUNTY does hereby find, determine and order as follows:
