Good Morning Supervisors,

Jon and I would like to express our support for the proposed amendments for the Outdoor Festival Ordinance. Change to Deltopia is not going to happen overnight. It is going to take a combination of education, ordinances and an alternative event to make Isla Vista safe on that week-end again.

We have seen absolutely horrific things happen on Deltopia. Unfortunately, the collective memory of the tragedies that have occurred fades every four years. The vast majority of current IV residents have not seen what has happened on that weekend over the past 15 years. When you have a combination of drugs, alcohol, unsafe cliffs and balconies, visitors with little to no understanding of our community and 25,000 people packed into a small area something has always gone wrong.

For years the worry was Halloween. We strongly believe the Festival Ordinance played a part in bringing this Holiday back to an event the whole community can support.

In terms of holding an Alternative Event for Deltopia, something on campus for that week-end would have the best desired result. If Extravaganza could be moved to that weekend it would give our students a spring party, and at the same time, discourage people living outside the community from coming in. We would need to think of ways to include SBCC students as they make up a large population of IV.

I have been told changing the date of Extravaganza is not something that can happen this year, maybe a different large event that weekend on campus? That said, we believe the collective community should start working with Associated Students, Program Board, appropriate University officials, the IVCSD and Law Enforcement ASAP to have something in place for next year.

Attached are photos Jon and I took on January 3-4, the recent king tides and major rain events have added to the fragility of the bluff. With these balconies, Del Playa Drive is not the venue for over 25,000 to party. If something were to happen to one of those balconies, the consequences would be heartbreaking.

Your passing this ordinance will be a step in the right direction toward safety and to help curb the influx of people from out of town.

In addition to the passage of this ordinance, anything that can be done in cooperation with property owners, the fire department, zoning officials or any other body to close off those balconies to large gatherings would be welcome.

While I am not against students having fun in their own rented homes, the possibility for holding long, loud parties draws young people from all over, making these weekends unpleasant and unmanageable. It is not just the music, but the screaming, car alarms, and even violence that regularly occur. Deltopia is particularly frustrating to my family, because it means that "our" beach (Coal Oil Point beach) is closed for the entire weekend for safety reasons, which we resent.

Prohibiting very loud parties is a first step to taking IV off of the map for this dangerous party culture.

“Dear Board Of Supervisors,

Thank you for taking the time to listen to the long-term residents of Isla Vista and the surrounding areas. As a resident who had the opportunity to stay in Goleta after graduating from UCSB in 2019, I understand the concerns from both long-term residents and short-term/transient residents, or more known as the student population. When I was an incoming UCSB student in 2014, Isla Vista faced one of the most tragic events to have happened, the Elliott Rodger shootings. This event, along with the Halloween riots in 2014, changed how we would experience student life in the next 4+ years. It was uncomfortable at first having to acknowledge the increase in police presence; however, to see a community coming forward to do what they can to make sure an event of that atrocity would never happen again was comforting. It was understood that Isla Vista is a unique community that needed to be preserved, protected, and kept out of reach by out-of-town visitors and residents. So for the next several years, local leaders, students, and the university made an effort to work towards a safer environment for the student population.

If you were to walk along Del Playa Drive or Sabado Tarde on a Friday or Saturday nighttoday, you would not believe the same town faced such tragedy years ago. The lack of care for Isla Vista is demonstrated by the student population’s constant failure to follow local laws, such as parking violations and open invites to parties that litter public spaces, and by elected leaders and university administration staff who fail to recognize Isla Vista as a place worth governing and providing innovative solutions for. I hope that you all consider passing this ordinance with intentions to collaborate and put pressure on the UCSB administration to work towards a sanctioned event for the UCSB students. The long-term residents, local health care and emergency services infrastructure, and everyone else who is affected by the Deltopia events would appreciate the effort and representation on this matter. Thank you for your consideration and ongoing support.”
