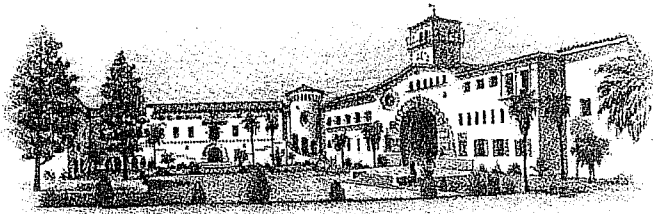

WHEREAS, The Righetti boys basketball team had another productive season, advancing to the quarterfinals of the CIF Division 2A playoffs and; and

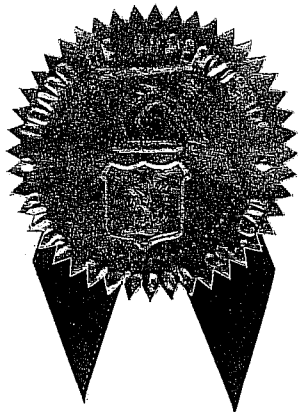
