- B. Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor in the amount of \$891,429.54.

#### **Summary Text:**

This project resurfaced a total of five (5.0) lane miles of roads. Construction included repair of failed pavement areas and placement of a Type B asphalt concrete overlay over pavement reinforcing fabric and asphalt concrete leveling course.

Additional work included drainage and road stabilization work in Summerland, full-width grinding Modoc Road to improve ride quality, and paving on the south shoulder of Call Real near El Sueno to allow parking and bike lanes.

The project was accepted as complete by the Director of Public Works on May 11, 2007.

This project was completed on time and under budget.
