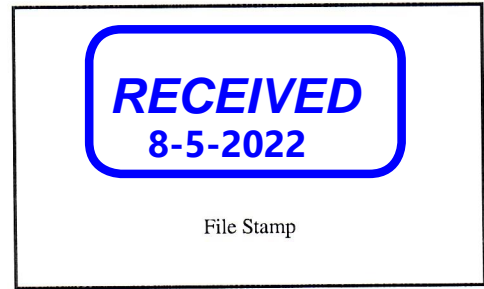


**DECLARATION OF CANDIDACY



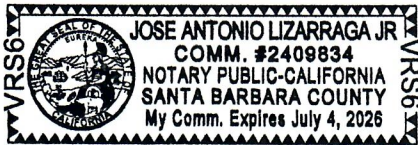

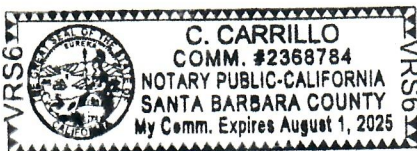
