That the Board of Supervisors:

- A. Approve plans and specifications for the Construction of 2003/2004 County Wide Measure 'D' Preventive Maintenance Application of Slurry Seal, County Project No. 820498;
- B. Award the construction contract in the amount of \$584,843.70 to the lowest responsible bidder, American Asphalt South, Inc., a California corporation (Not A Local Vendor), P.O. Box 3610, Fontana, California 92334, subject to the provisions of documents and certification, as set forth in the plans and specifications applicable to the project and as required by law:
- C. Authorize the chair to execute the construction contract upon return of the Contractor's executed contract documents and the review and approval of the County Counsel, Auditor Controller and Risk Manager or their authorized representatives:
- D. Approve a contingency fund in the amount of \$41,742.19 for the Construction of 2003/2004 County Wide Measure 'D' Preventive Maintenance Application of Slurry Seal, County Project No. 820498.

# On Thursday, June 5, 2003, seven (7) bids were opened for the Construction of 2003/2004 County Wide Measure 'D' Preventive Maintenance Application of Slurry Seal, County Project No. 820498. American Asphalt South, Inc, a California corporation, submitted the lowest responsible bid in the amount of \$584,843.70, which was 17% below the Engineer's Estimate. Staff has performed an analysis of the bids received and has determined that the low bid is responsible and reasonable. Staff recommends awarding this contract to American Asphalt South, Inc.

The project is one of the strategies the Department employs in its annual Preventive Maintenance Program and consists of the application of a slurry seal coat on the existing pavement surface at various locations throughout Santa Barbara County. Approximately 58 lane miles of County maintained roadway will be resurfaced with construction of this project.

Your Board approved the project as part of the 2003/2004 Capital Improvement Plan. The specific project locations were approved by your Board in the FY 2003/2004 Road Maintenance Annual Plan (RdMap) and attached for your information.

This project was bid in accordance with the Public Contract Code, which requires the award to the lowest responsible bidder.



# Mandates and Service Levels:

No change in programs or service levels.

## Fiscal and Facilities Impacts:

In fiscal year's 2001/2002 through 2003/2004 the Department received a total of \$4,156,262.87 in AB 2928 revenues. These revenues are derived from fuel sales taxes collected and received by the State General Fund. These moneys were specifically designated for the purpose of road maintenance needs throughout the unincorporated areas of the County. Additionally, AB2928 funding is required to be utilized within an eighteen-month period. To achieve the criteria on the funds discussed above, the Department shall utilize the remaining funds available in the sum of \$155,328.21, which typically are programmed for Measure 'D' revenues. This process allowed an equal amount of Measure 'D' revenue to be re-programmed into the Measure 'D' Program of Projects approved by your Board on March 11th, 2003. The remaining funding for this project shall be Measure 'D' in the amount of \$471,257.68, for a total project funding amount of \$626,585.89.

AB2928 funding for this project is budgeted in Fund 0015, Org Unit 0001, Program 2900, Department 054 and Account 7512. Measure 'D' funding for the project is budgeted in Fund 0015, Org Unit 0002, Program 2900, Department 054 and Account 7511.
